

EYSA BOARD MEETING – AUGUST 24, 2014

The meeting was called to order by President Minner at 7:18PM.

By motion of Todd Haines, second by Rob Cymbor, the minutes of the May meeting were adopted.

During the President's report, President Minner discussed utilizing Sign Up Genius to help make things easier for the Equipment person to make sure things are getting done with assistance. Coaches were listed and approved by vote with lists presented; boys director separately submitted a list of assistant boys coaches for approval.

Vice president Carr had nothing to report.

Secretary Creamer was unable to attend. President Minner discussed his attendance at the RBJSJL meeting noting the upcoming coaches meetings. Registration across the county is down. Games scheduled to begin the weekend of September 6. Twin Valley has completely pulled out of RBJSJL. There was some discussion and the Board agreed to have Lanco rep come and talk to the Board.

Treasurer Cymbor submitted his report in writing, specifically noting that we the Tournament held in May netted a \$1500 profit to the Club.

Registrar Wilson noted that 11 teams were not yet approved due to missing information and she wants everything done within the next week. The rosters freeze on September 14, 2014.

Boys Director and Girls Director had nothing to report.

U5-U6 coordinator Bryan Smith noted that he received a lot of thank you for the T-shirts handed out to the rec coaches. There was also some discussion of who is responsible for canceling due

to weather. Mr. Smith also noted that he received information regarding U8 play days in Oley that he would like to explore and potentially participate in. He was asked to follow up regarding insurance issues.

U7-U8 coordinator noted the ongoing need for referees on Thursday evenings for the U8 group. There was also brief discussion regarding the miscommunication with the U7/U8 uniforms and the need to address the problem before next year.

Coaching/Player Development noted that sessions begin Monday and there will be no sessions the week of Labor Day.

Field/Equipment Coordinator advised that Tom Legath approved EYSA getting soil from Ridgewood; going to run it by Ken Pitts as well. Need to move goals from Lower Lausch to Jacksonwald and goals from Jacksonwald to Lower Lausch. Also noted that games should be played even if it is raining as long as there is no thunder or lightning.

Website coordinator was absent.

Under New Business, we discussed the Picnic, the September 3 Dairy Queen night, and the September 17 Youth Night at the Exeter boys soccer game.

Cindi Wilson advised the Board that she will be stepping down as Registrar effective December 31, 2014.
