#### EYSA BOARD MEETING -November 16, 2014

Meeting called to order by President Bryan Minner at 7:02pm.

Approval of October minutes Nicole Henry motioned. Cynthia Wilson seconded.

### President's Report:

Bryan Minner reported about RBJSL November meeting and "relegation" discussion that occurred between some clubs at the meeting. EYSA is trying to figure out a way to prevent "blowouts" in divisions due to mostly T1 teams playing T2 and premier players playing in all divisions. EYSA will take a proposed motion from our club to be brought to the table for the December RBJSL meeting. RBJSL will then ask all clubs to vote on this in the January meeting.

# EYSA proposal for MOTION:

EYSA proposes that RBJSL move forward with the 2015 Fall season with the new relegation regulation that ALL T2 teams do not participate in the playoffs. In addition, EYSA proposes that RBJSL PROHIBIT all NON-RBJSL secondary players from playing for a RBJSL T3 team.

Brian Minner also proposes a new policy to be added to the website and Coach Manual

EYSA Tournament policy's purpose is to ensure the safest and fairest field of play for all children enrolled in EYSA soccer.

- 1) Coach must present the tournament to the board with paper work proving that it is an EPYSA sanctioned tournament. Non EPYSA sanctioned tournaments will not be allowed to be played as an EYSA team. An EPYSA sanctioned tournament will ensure each child is covered by insurance offered through EPYSA as a registered player
- 2) All players of your current team (fall or spring depending on time of year) will be asked to play
- 3) If you cannot field a full roster with your full team then you may ask players of other teams only after asking the coach of the team in which the player is playing on if they will be doing a tournament. If the other team is playing in a tournament the player must play on his/her primary team.

### THE ABOVE WAS PUT UP FOR A VOTE

Rob Cymbor moves that above policy is added to EYSA club and Cynthia Wilson seconds.

Bryan Minner spoke about dialogue club had w Governor Mifflin, Oley, Conrad Weiser. EYSA would like to "prep" U12 players for 11v11 play. This will be accomplished by scrimmages between clubs between

April and May. Possibly 6 scrimmages per club. There will be RBJSL refs. A commitment fee of \$20 per player will be required. The second purpose will be to invite all Junior High coaches to watch/help. The club pool will ONLY be for rostered players from fall 2014 or spring 2015. It "may" include U11??

Bryan spoke in length regarding the RU Tournament. As a club, this was VERY labor intensive on top of a lack of volunteers. EYSA will go to RU to ask for more of a cut of the profits. If that doesn't work in 2015, then the following year will be a "club effort". We will organize tournament ourselves in conjunction w other clubs.

Bryan reports that EYSA Exec Board will have a meeting w other Exec Boards on Dec 9 to brainstorm things.

Treasurer- Cynthia Wilson nominates Rob Cymbor. Kelly Carr seconds.

Again, this is for ALL volunteer tasks that need to be filled in this program. If they are not, EYSA will raise registration fees and hire a helper similar to Little League.
